Customs Clearance

Dear Client

Here are the procedures when arriving at JHB International

- 1). Clear passport control where the flight arrives.
- 2). Proceed to baggage claim at the relevant carousel.
- 4). Proceed to the South African Police Firearms Officer where you declare the firearms and finish clearance procedures, and receive temporary import permit issued for 90 or 180 days.

Please make sure that **all** your firearms are declared on the temporary permit.
No more than **one** firearm per calibre and **200** rounds per calibre will be allowed into the country. **60 should be sufficient**
Permits will only be issued for ammunition that is accompanied by a firearm of the same calibre.

Temporary Import Permits will not be issued to anyone under the age of 21.
No Temporary Import Permits will be issued for **semi-automatic** or **automatic** rifles.

There is no permit required, nor any charge by the South African Police Service for a bow or for a blackpowder rifle.
